

**METROPOLITAN PLANNING ORGANIZATION**  
**TECHNICAL ADVISORY COMMITTEE**

A meeting of the Indian River County (IRC) Metropolitan Planning Organization Technical Advisory Committee (MPOTAC) was held at 10:00 a.m. on Friday, November 21, 2008, in Conference Room "A1-A11" in Building "A" of the County Administration Building, 1800 27<sup>th</sup> Street, Vero Beach, Florida.

**Call to Order**

Chairman Nunemaker called the meeting to order at 10:02 a.m., at which time it was determined a quorum was present.

**Approval of Minutes from the October 31, 2008 MPOTAC meeting**

**ON MOTION by Mr. Keating, SECONDED by Mr. Menger, the members voted unanimously (13-0) to approve the minutes of the October 31, 2008 Metropolitan Planning Organization Technical Advisory Committee as presented.**

Mr. Phil Matson, IRC MPO Staff Director, reported IRC staff had recently taken over the visual recording of public meetings and providing footage for the local cable television station, Channel 27. He continued a promotion for GoLine was recorded for showing on Channel 27 explaining the public transportation system. It emphasized the new donation program being put in place on all the buses.

Ms. Karen Wood, Senior Resource Association, showed the new lockboxes being installed in the buses for the contributions.

**Presentation of FY 2009/10 – FY 2013/14 Draft Tentative Work Program by Florida Department of Transportation (FDOT) – Action Required**

Mr. Jim Davis arrived at 10:08 a.m.

Mr. Matson explained every year at this time the FDOT reads the IRC Priorities Project Report which was approved by the MPOTAC in September, 2008, included in the agenda packet and on file in the Commission Office, as they consider the Five Year Tentative Work Program.

Mr. Matson related the Five Year Tentative Work Program was FDOT's project programming and financing schedule for transportation projects within the MPO area, and must be developed with consideration of the MPO's 2008 highway, enhancement, congestion management system, transit and aviation priorities.

He introduced Ms. Stacy Miller, FDOT District Management Engineer. Ms. Miller presented the Draft Tentative Work Program for FY 2009/10 – FY 2013/14. A copy of this document is on file in the Commission Office. Three other items distributed to the members were a map of all the intended construction projects over the draft tentative work period; a Citizen's Plan which was the entire draft tentative work program for IRC; and a status of key projects listing. All of these documents are also on file in the Commission Office.

Ms. Miller reported the FDOT was legislatively mandated to preserve the state highway system and that priority came before capacity improvements. She stated whatever funding was left over after providing for preservation and safety would then go to capacity improvements.

Ms. Miller related their funding came from the federal government and state gas tax revenues. She explained since November, 2006, the FDOT has been receiving less revenue, totaling \$6.5 billion, in the State Transportation

Trust Fund which was basically gas tax revenue. In District 4 alone, \$205 million had been lost. Other areas where funds were lost were as follows:

- \$18 million in public transit area
- Impacts to the strategic intermodal system and the TRIP program
- Sales tax and documentary stamps

Mr. Mora arrived at 10:18 a.m.

Ms. Miller reviewed the Status of Key Projects. Lengthy discussions ensued regarding the various funding sources. Ms. Miller pointed out more budgetary cuts were being done today and changes would be made to the documents for the MPO meeting scheduled for December 10, 2008.

Mr. Matson inquired if the funding for a bus scheduled to run between St. Lucie County and Vero Beach would remain on the list. Ms. Miller replied it was still on the list at his time to begin in July, 2009.

Chairman Nunemaker and Mr. Davis left the meeting at 11:00 a.m. Vice Chairman Mora then continued the meeting.

**ON MOTION by Mr. Keating, SECONDED BY Mr. Griffin, the members voted unanimously (13-0) to recommend the Metropolitan Planning Organization endorse the Draft Tentative Five Year Work Program for Fiscal Years 2009/10 through 2013/14 with amendments that may come forth at the December 10, 2008 Metropolitan Planning Organization meeting.**

Mr. Matson pointed out the 2009 meeting schedule contained in the agenda packet, a copy of which is on file in the Commission Office.
