NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Board of County Commissioners of Indian River County, Florida shall hold a public hearing at which parties in interest and citizens shall have an opportunity to be heard at its regular meeting held on Tuesday, March 16, 2010 at 9:00 a.m. or as soon thereafter as the matter may be heard, in the County Commission Chambers of the County Administration Building A, located at 1801 27th Street, Vero Beach, Florida. The title of the proposed ordinances is as follows:

AN ORDINANCE OF THE BOARD OF COUNTY COMMISSIONERS OF INDIAN RIVER COUNTY, FLORIDA AMENDING TITLE X, IMPACT FEES, OF THE CODE OF INDIAN RIVER COUNTY, AMENDING CODE SECTION 1000.06 "IMPOSITION" TO PROVIDE AN EXCEPTION TEMPORARILY SUSPENDING FOR ONE YEAR THE IMPOSITION OF IMPACT FEES FOR FIRE/EMERGENCY SERVICES FACILITIES, CORRECTIONAL FACILITIES, PUBLIC BUILDINGS DEVELOPMENT, LAW ENFORCEMENT, AND SOLID WASTE FACILITIES; AND, PROVIDING FOR CODIFICATION; SEVERABILITY; AND EFFECTIVE DATE.

Said ordinance, if adopted, will temporarily suspend impact fees for correctional facilities, solid waste, public buildings, fire/emergency services, and law enforcement for one year, from April 1, 2010 until March 31, 2011, in order to stimulate the county economy.

A copy of the proposed ordinance will be available at the Planning Division office located at the County Administration Building, 1801 27th Street, Vero Beach, Florida, beginning March 1, 2010. After March 10, a staff report and the draft ordinance may be found on the county's website at www.ircgov.com. Anyone who may wish to appeal any decision which may be made at this meeting will need to ensure that a verbatim record of the proceedings is made, which includes testimony and evidence upon which the appeal is based.
