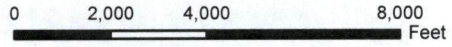

LOCATION OF OPEN SECTOR 3 BEACH PARKS

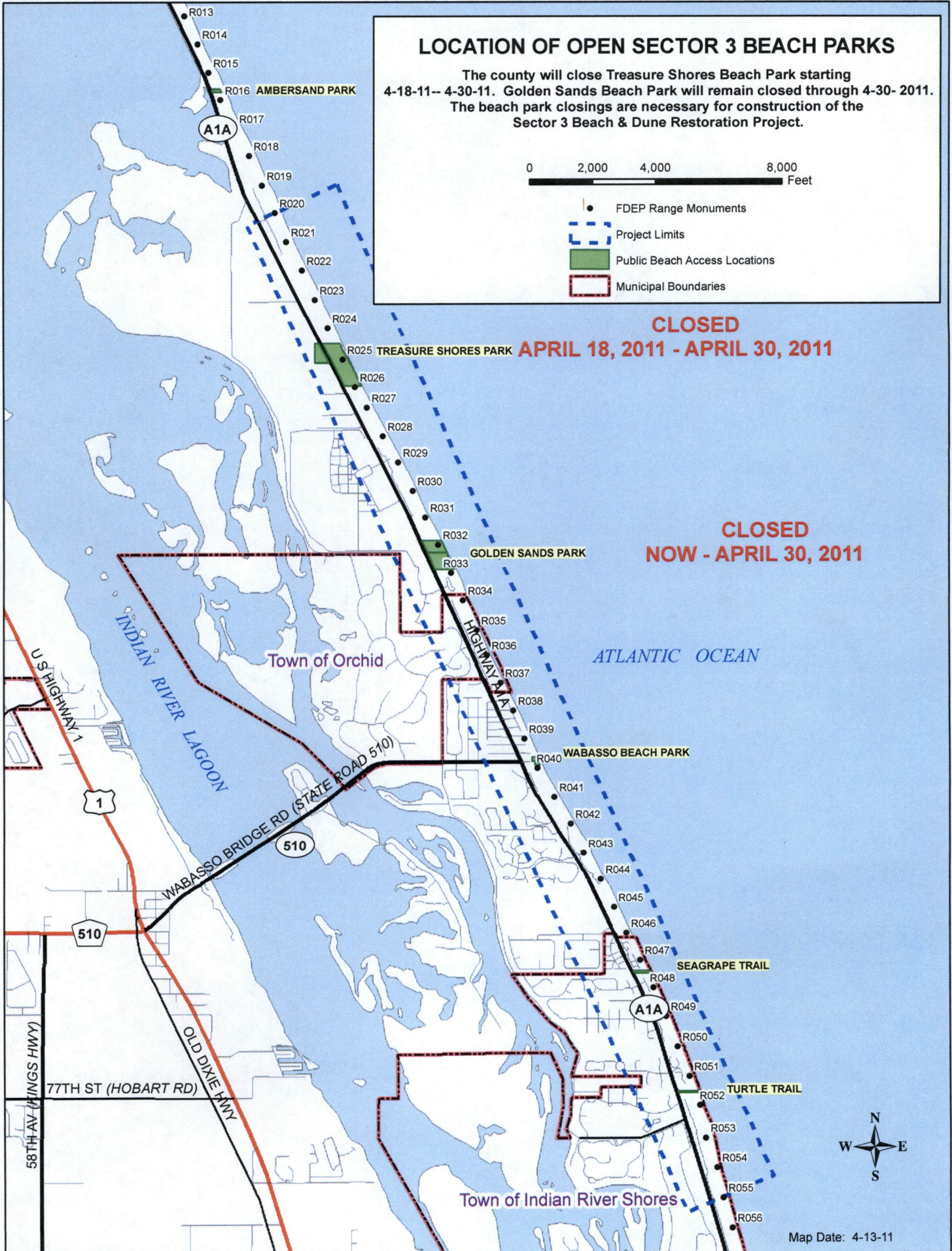
