She asked the Board for their approval to hold and sponsor a Residential Paper Shredding Event on Saturday, April 2<sup>nd</sup> from 10:00 a.m. until 1:00 p.m. and would like to do this event in tandem with the Indian River Green Market Event being held from 10:00 a.m. until 6:00 p.m. at the Indian River Mall.**

**Marketing Coordinator Fonvielle announced the Electronics Collection Event will be held at the Indian River County Fairgrounds on Saturday, April 30, 2016.**

**ON MOTION by Commissioner O'Bryan, SECONDED by Chairman Solari, the Board unanimously approved and authorized participating in the 2016 Green Market at the Indian River Mall with a sponsorship in the amount of \$1,500 and sponsoring a Residential Paper Shredding Event utilizing Progressive Document Destruction, LLC, in the amount not to exceed \$1,600.**
