SUBJECT: TRANSPORTATION DISADVANTAGED ANNUAL PUBLIC HEARING

To help local governments fulfill the functions of transportation disadvantaged planning, the State Commission for the Transportation Disadvantaged (CTD) requires that all counties appoint a Designated Official Planning Agency (DOPA). The DOPA must fulfill responsibilities and duties as outlined in Chapter 427, Florida Statutes, and Rule 41-2. Starting January 1, 2000, the Indian River County Metropolitan Planning Organization became the county's Designated Official Planning Agency.

As part of the statutory responsibilities, the Indian River County Metropolitan Planning Organization appoints members to the Indian River County Transportation Disadvantaged Local Coordinating Board (TDLCB) to assist in the coordination of transportation disadvantaged services within the county. The purpose of the TDLCB is to identify local service needs and to provide information, advice, direction, and support to the Community Transportation Coordinator, the Senior Resource Association, Inc.

The TDLCB is required by the State Commission for the Transportation Disadvantaged to hold an annual public hearing in order to gather public input on transportation disadvantaged related issues. At this time, the Transportation Disadvantaged Local Coordinating Board (TDLCB) is inviting all interested citizens to a public hearing to discuss transportation disadvantaged issues and to provide input to the Local Coordinating Board on transportation services (demand response and fixed route) and unmet needs.
