Driveway/Slab/Structural Slab Permit Checklist

The following items are required with submission of your permit application:

- A completed Indian River County/City of Vero Beach <u>Scope of Work</u> permit application.
- Owner/Builder Disclosure Statement when applicable.
- Documentation that verifies job value. Examples include a copy of the signed contract between the owner and contractor or a signed estimate, etc.
- Residential and Commercial permits must include a detailed scope of work either provided on the application or as an attached document.
- Driveways and Non-structural slabs require the below information to be submitted:
 - 2 copies of a legible survey or site plan with the proposed driveway or slab which indicates the slab dimensions along with distances from structures and property lines.
 - Indicate the proposed thickness of the driveway/slab along with minimum concrete strength (PSI).
- Structural slabs (Foundations) require a \$200.00 submittal fee and require the below information to be submitted:
 - 4 copies of a legible survey or site plan with the proposed foundation which indicates foundation dimensions along with distances from structures and property lines.
 - 4 copies of foundation plans provided by a Florida licensed Design Professional. If foundation is for a
 future building applicant will need to provide foundation requirements for the new proposed structure by
 a Florida licensed Design Professional.
- All permit applications also require approval from the Planning Department having jurisdiction.
- Environmental Health Dept. approval is required for all sites that either have a septic system or a well.
- Permit applications will also require approval from the Public Works Department having jurisdiction when the below conditions exist:
 - Proposed driveway is located in the Right-of-Way.
 - Structural Slabs (Foundations)
- Driveways and slabs that either abut a structure or is located within 12" of a structure will require Termite Treatment that complies with the Florida Building Code.
- A Recorded Notice of Commencement (NOC) preferred to be submitted with application but must be submitted
 prior to first inspection if job value exceeds \$2500.
- Applicants are advised that Building Permit Applications are considered incomplete until all other IRC/COVB Departments and other Governmental agency reviews are completed and approved. The Building Permit Application will be routed to other departments, even if considered incomplete, in order to expedite the review process. The Building Permit Application review and approval time clock does not start until the application is deemed a Complete Application.
